## WHEREAS:

- A. Rx and the Promoter Companies had executed the Undertaking as part of the Closing exercise in relation to acquisition of Sale Shares of Crescentia Labs Private Limited ("Company"), in accordance with the share purchase agreement dated April 24, 2023 executed between the Company, Promoter Companies and Rx ("SPA").

- 1.2. In Paragraph 3.2 (Additional Representations and Warranties) of the Undertaking, the following shall be inserted after Paragraph 3.2.9:

"3.2.10. The Promoter Companies represent and warrant that the list of Company Personnel set out in Annexure 3 herein is the complete list of any personnel employed or engaged (each whether directly or indirectly) by the Company, prior to Closine.







## 2. Miscellaneous

Except to the extent provided for herein, this ATU does not and shall not be construed to modify any other terms or conditions of the Undertaking and the same shall continue to be in full force and effect. All references to the Undertaking in any document shall mean and include a reference to this ATU.
- 2.3. <u>Complete Agreement</u>: The Undertaking, as supplemented by this ATU, constitutes the entire agreement among the Parties relating to the subject matter, as stated in the Transaction Documents.
- 2.4. <u>Execution</u>: This ATU may be executed in counterparts, including counterparts transmitted by adopting any electronic mode, each of which will be deemed an original, but all of which together will constitute one and the same instrument.
