Price Variation

The price quoted/confirmed is based on the labour cost as on the date of quotation and for the equipment price is valid (i) till the order loading to factory as agreed in the Contract or 1 year from the date of contract, whichever comes earlier and for the installation price shall be valid (ii) till the date of starting installation as agreed in the Contract or 18 months from the date of contract, whichever comes earlier.

In the event of project delay due to reasons attributable to Customer / owner beyond the validity period as mention above for point (i) and (ii), the price shall be subjected to an escalation of 05% year on year.

The same shall be payable by Customer at the time of amending the order and before start of Installation. If this price variation provision is incorporated in the proposal for more than one elevator, it shall be applied separately to the portions of the price allocated to each elevator.

4. Statutory permissions from various authorities

All statutory permissions for starting / executing, completing and handing over the works from various authorities including PWD shall be obtained by the Customer. Fees or any other payments required to be paid, for concerned liaison for getting above work done shall be paid directly by the Customer. IMEC shall coordinate for inspections required as per statutory requirements as applicable on the date of this Contract. However any fees, charges towards license inspectorates and incidental charges for certification of works will be to the Customer's account.

5. Installation

IMEC shall start with Installation at site after following conditions are met:

- a. Completion of all technical activities at site as per the IMEC check list
- b. Fulfillment of Payment Terms as agreed in the Contract.
- c. Availability of necessary statutory requirements from authorities as per local law.
- d. If the handing over of the site is delayed from customer side then the installation will be deferred so as to synchronize with the site completion. In view of this, customer will have to grant us the necessary extension in the completion period without imposition of any conditions.
- e. If during the inspection of site, IMEC observe that there is a delay in completion of the hoist way structure or availability of power supply, IMEC may at its discretion delay the final assembly of materials and in such an event, a revised completion date will be established depending upon IMEC present work load. In view of this, customer will have to grant IMEC the necessary extension in the completion period without imposition of any conditions.
- f. The site should be ready in all aspects to commence installation immediately or maximum within a period of Fifteen (15) days upon receipt of materials at site. In the case of non-readiness of site to commence installation beyond Fifteen (15) days, there will be a corresponding price and time implication towards re-mobilization.

6. Handing over

Upon completion of installation, IMEC erection crew will test and adjust the lift(s) and shall notify two (2) weeks in advance for customer taking over the elevator(s). Customer usage of the elevator(s) will not be permitted until it is officially taken over by the customer.

IMEC do not take any responsibility for delayed handing over of the lift, if the terms of payment are not observed or if Customer obligations as specified are not fulfilled in time or if formalities are delayed due to non-payment of fees or if necessary technical details are missing etc., are not received by IMEC in time without prejudice to IMEC claims under this contract.

If there is any delay in completing the Government inspection formalities due to the reasons attributable to the customer, the elevator(s) will be handed over to the customer and the Free Maintenance Period is deemed to have commenced from the date the elevator(s) are offered to customer for inspection, by IMEC.

7. Ownership of material

Till the final payment is made, the Customer cannot claim right of ownership or lien over any materials. IMEC shall have the right to take back/reclaim the possession of the same or any part thereof at the Customer's cost if the Customer fail to make payment as per clause 10 of Master Service Agreement that is Terms of Payment. In case the payment is not made as per the terms of

the Contract, IMEC shall have the right to dismantle its elevator / escalator and take the materials supplied back in its possession. This will be without prejudice to IMEC's legal right to recover the unpaid amounts, interest, legal expenses and the cost incurred in dismantling the elevator(s) / escalator(s), logistics cost of moving the same, labour cost arising with such dismantling/moving and all the applicable taxes / duties / cess. IMEC is not bound to furnish any documentary proof in support of such recoveries. The depreciation in the value of the material/resale value shall also be taken into account. 8. Free Maintenance Period

IMEC free maintenance shall be for a period of 12 months, and will commence from the handing over date of each elevator (approx.. by 31-10-2025) or 18 months from the date of intimation that material is at warehouse whichever is earlier. The date of commencement of free maintenance will remain unchanged, irrespective of any delay in building completion, availability of permanent power supply, inspection taking over, or commencing use of the elevator.

Maintenance will consist of regular examinations and any necessary adjustment and lubrication of the equipment by the competent employees under IMEC direction and supervision. The required supplies and parts will be furnished except such parts as may be needed because of negligence, misuse or accidents not caused by IMEC. All work will be performed during IMEC regular working hours of IMEC regular working days except for emergency minor adjustment call back service, which will be provided during regular working hours and also during any overtime hours. No work or service other than the specifically mentioned is included or intended.

IMEC shall not be liable for any loss, damage, or delay due to any cause beyond our reasonable control including but not limited to acts of government, strikes, fire explosion, theft, floods, riots, civil commotion, war, malicious mischief or act of God. Under no circumstances shall IMEC be liable for consequential damages.

9. Warranty

The warranty for the equipment shall be for a period of 18 months from date of intimation from IMEC that material is ready for shipment at warehouse or 12 months from the, handing over date (approx.. by 31-10-2025) of each elevator, whichever comes earlier, and IMEC will rectify and make good any defects, not due to ordinary wear and tear, improper use, or lack of care, which may develop during this period.

This warranty (a) does not extend to consequential loss and/or damages and (b) is null and void in case of tampering and/or if maintenance, repairs and modifications are carried out by the unauthorized passens.

10. Payment and Free Maintenance for Multiple Units

Every elevator in a contract of multiple units will be considered as individual equipment. The commencement of free maintenance and final payment for each elevator will not be linked to any other elevator of the group or of the Contract. IMEC shall be entitled to payment and commence free maintenance period as and when each elevator is completed physically. IMEC shall have the right to suspend the installation activities for other units in the group, due to delay in the final payment of the earlier elevator. 11. Insurance

IMEC shall take necessary Erection and All Risk Insurance coverage for supply and installation elevators at the Customer's site.

12. Reconditioning / Replacement of Materials

In case the materials / components at project site cannot be installed due to non-availability of proper hoist way, power supply issue, theft, pilferage & improper storage resulting in delays attributable to customer, IMEC seek redressal on the following as per the mutually agreed terms / conditions:

- Extension of time for Installation & Commissioning
- b. Investigation on the condition of materials due to one or all the reasons mentioned above
- c. Extra cost & revision in the contract value due to reconditioning / replacement of components

13. Cancellation / Termination of Contract

In the event of cancellation or termination of the Contract by customer/client during any of the milestone as stated below, IMEC shall be entitled to claim as follows:

- i. 20% of the Contract Value if the cancellation is before approval of layout drawings
- ii. 70% of the Contract Value if the cancellation is within one month of final approval of layout drawings.
- 85% of the Contract Value if the cancellation is after one month of final approval of layout drawings.
- iv. 100% of the Contract Value if the cancellation is after the installation has started.

14. Default

This will be without prejudice to our right to recover the unpaid amounts and interest by any means or process or proceedings whatsoever. GENERAL TERMS AND CONDITIONS

1. Price Variation

The price quoted/confirmed is based on the labour cost as on the date of quotation and for the equipment price is valid (i) till the order loading to factory as agreed in the Contract or 1 year from the date of contract, whichever comes earlier and for the installation price shall be valid (ii) till the date of starting installation as agreed in the Contract or 18 months from the date of contract, whichever comes earlier.

In the event of project delay due to reasons attributable to Customer / owner beyond the validity period as mention above for point (i) and (ii), the price shall be subjected to an escalation of 05% year on year.

The same shall be payable by Customer at the time of amending the order and before start of Installation. If this price variation provision is incorporated in the proposal for more than one elevator, it shall be applied separately to the portions of the price allocated to each elevator.

In the event customer/owner proposed for extension of the price variation beyond the validity without escalation of the price contract, IMEC shall has right to terminate the contract with noticing 60 days in advance, without being payable of any amount to customer, including advance payment made to IMEC.

2. Security Export Control

The Customer shall not use any goods, technologies and/or software supplied from IMEC in relation to development, production, use or weapons of mass destruction, or shall not transfer such items to any third party should the Customer know or suspect that those could be used for such an application. In case there are any price escalation, same shall be agreed between the parties. Nevertheless, if there is no communication from customer for the idle materials for period of 30 days from the date of last communication from IMEC, customer agrees to cancel the contract and necessary action shall be Initiated as per the Cancellation/ Termination of Contract clause.

If the contract is executed to any stage and then abandoned due to reason attributable to customer

22. Deemed Acceptance:

During the performance of this contract or on completion of any scope of service as agreed in this agreement, customer agrees to provide acknowledgement and confirm the receipt, for all the Communications, including invoice, letter etc., [documents] sent via post or email or courier by Mitsubishi Elevator India Pvt Ltd [IMEC]. In case of any dispute with regards to any of the documents, customer shall inform within 7 business days to IMEC, failing which the said documents shall be treated as deemed accepted by the Customer

23. Successors and Assigns

The provisions of this Contract shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and permitted assigns.

24. Assignment

Neither party shall, without the prior written consent of the other party, assign any of its rights or delegate any of its duties under this Contract to any third party.

25. Dispatch of Material

The Customer agree to pay IMEC an additional charge Rs.1,000/- per day per elevator towards the demurrage and warehouse expenses from the date of ready to dispatch, under following conditions;



a. Request from Customer to delay the delivery of materials at site after start of manufacturing

 There is a delay in payment by the customer against "ready for dispatch advice" as per the contract (as applicable)

In this event, the completion date shall be revised accordingly and a new completion date shall be mutually agreed upon.

26. Anti-Bribery and Anti-Corruption

Each Party represents and warrants that it has not and will not directly or indirectly pay, offer, give or promise to pay or authorize the payment of, any portion of the compensation or reimbursements received hereunder or any other monies or other things of value to an officer or employee of a government of any department, agency, or instrumentality thereof, an officer of employee of a public international organization; any person acting in an official capacity for or on behalf of any government or department, agency, or instrumentality or public international organization; any political party or official thereof; any candidate for political office; or any other person, individual or entity at the suggestion, request or direction or for the benefit of any of the above-described persons and entities, or engage in acts or transactions otherwise in violation of any applicable anti-bribery legislation, including but not limited to the Indian Prevention of Corruption Act, 1988.

Each Party hereby covenants and agrees that it and its employees and authorized agents will comply with the obligations set out in this Section and Indian Anti Bribery Law and any applicable anti-bribery legislation specified herein, and acknowledges that the other Party's entering into this Contract is conditioned upon such representation and warranty.

Any action by a Party or its agents determined in good faith by the other Party to be in contravention of this Section shall result in termination of this Contract and any other business relationship between the Parties.

27. Authorized Signatory

Authorized Signatory is the designated representative of the Customer's organization who is authorized to make commitments under this Contract. Execution of this Contract shall imply that the executant has the capacity and authority to enter into this Contract for and on behalf of his/her organization.

28. Indemnification:

Customer shall indemnify and hold harmless the Contractor, its officers, directors, employees, from and against those liabilities, damages and costs that Customer is legally obligated to pay as a result of the negligence of customer there is damage to any person or the destruction or damage to equipment, to the extent caused by the willful misconduct, negligent act, error or omission of the Customer or anyone for whom the Customer is legally responsible, subject to any limitations of liability contained in this Agreement. Customer will reimburse Contractor actual cost of the materials.

29. Amendment to Contract

Any amendment to the contract after manufacturing of the materials as per the contract, parties agree to sign new contract with agreed terms and conditions, which shall not be consider under the old contract which is agreed earlier for the same project.

Appendix III

CUSTOMER CONTRACT OBLIGATIONS FOR ELEVATOR INSTALLATION

Elevator Hoist way

PIT:

- 1) Pit depth shall be complied as per the approved IMEC layout drawings
- Pit shall be clean and free from water, debris and dust, duly plastered and whitewashed before elevator installation.
- 3) Pit waterproofing is mandatory before elevator installation.
- 4) Removal of unwanted rods projected in pit.
- 5) The space underneath the pit must not be occupied.

Elevator Entrances:

- Provision of minimum 300 mm height RCC lintel at every floor to the entire width of the shaft to fix the elevator entrance equipment as per IMEC layout drawing.
- Finished Floor level to be marked at all floors inside / outside of the shaft before elevator installation.
- Entrance opening, cut-out for hall call button, position indicator, FE/FER switches etc. to be provided as per IMEC layout drawing.
- To provide lockable type full height steel barricades with kick plate for the elevator entrances during installation.

Elevator Shaft:

- Elevator shaft shall be constructed as per approved IMEC layout drawing, dry and free from water, debris and dust, illuminated, ventilated, duly plastered & whitewashed before elevator installation
- Overhead should be complied as per the approved IMEC layout drawings.
- Smoke vent hole to be provided as per approved IMEC layout drawing to meet fire department regulations.
- 4) Separator beams to be provided and fixed at every bracket span before elevator installation as per approved IMEC layout drawing when the hoist way dimensions exceed the standard allowable requirement or elevator shaft constructed by brick, hollow or pre-cast concrete (if applicable).
- ISMB / RCC Band to be provided at Bracket span levels as per the approved IMEC layout drawing when the elevator shaft is constructed by brick.

- 6) Support angles for entrance jambs to be provided when the hoist way is constructed by brick, hollow or pre-cast concrete as shown in IMEC layout drawings.
- Removing of unwanted rods projected in shaft, closure of any holes (Tie rod holes) or unwanted openings in the shaft before elevator installation.
- 8) Provision of scaffolding with working platform and double earthing for Installation activities as per the scaffolding sketch, adjustment of it whenever required and dismantling the same after erection works are completed.
- Hoisting beams or hooks to be provided in the ceiling in case of machine room less elevator (MRL) as per IMEC layout drawing.

Electrical works

- Provision of shaft lightings (two-way switch control at bottom most and top most floors for bulk head light operation).
- Provision of 15-Amps switch socket with bulk head light at every floor inside shaft as per IMEC layout drawing.
- Provision of single phase uninterrupted power supply (230 V & 15 A) at every alternate floor for elevator installation purpose.
- 4) Provision of suitable earth bar strip inside the elevator shaft near the overhead area.
- Provision and fixing of required isolators as per IMEC layout drawing plus cable supply and installation from electrical room.
- 6) Provision of uninterrupted power supply 380-415 V, 30 A, 50Hz, 3 Phase and 220-240 V, 15 A, 50 Hz, 1 phase in the top most floor with necessary accessories and terminating in suitable main switches for power and lighting circuits with MCB's, proper earthing and other protective devices necessary to meet legal code requirements.
- Provision of three phase power supply with separate breaker for group control panel (415V, 50 Hz) in top most floor properly terminated and grounded.
- 8) Provision and lying out of piping & cabling from elevator top most floor or hoist way to the building lobby / security office / control room as applicable for the Interphone / Telephone / BMS / Supervisory board / MELEYE, signal leads, emergency power control, fire alarm, CCTV, card reader etc.
- In case of WOS (Without Scaffolding) installation method, uninterrupted single phase power supply with 220 –240V / 16A / 50 Hz to be provided.

Store Room

 Provision of suitable safe lockable storeroom arrangement with proper lighting at ground floor of project site nearer to the elevator shaft with safe access to safeguard elevator materials till contract completion period.

- Pest control availability.
- 3) Provision of no open trenches, drainage path or cut-out to protect materials against rodents and water.
- 4) Any unloading/shifting of materials from the desired decided location during contract finalization, shall be payable by the customer at additional cost as agreed by both the party on the day of request for shifting, any multiple shifting of materials cost shall not be borne by the IMEC.
- 5) If truck (S) gets detained in the site because of the reasons not attribute to IMEC, detention charges will be claim at actuals to the customer.

Others

- 1) If there is a tower crane facility at site, the elevator contractor should be allowed its use free of cost for hoisting machinery to the top most landing/ last landing floor.
- 2) If need arises for multiple shifting of elevator materials from the main stores, the same shall be carried out by customer.
- Minor builder works (MBW) like chipping / grouting related to elevator installation works.
- 4) Permission to use building side hoists at free of cost by our Installation staffs to effectively carry out installation activities.
- 5) Architectural finishing of the machine room floor, walls and floors in the vicinity of the entrance hall after installation has been completed.
- Countermeasure for direct sunlight on elevator entrance doors with provision of sunshade.
- Countermeasure for special environment.(If any) 7)
- The power consumed in installation work and test operations to be provided. 81
- Supply and fixing of marble / granite for elevator flooring.
- 10) General housekeeping in elevator lobby at all floors and dispose of elevator material wooden crates at suitable places.

Dismantle jobs (if required).

- 1) Protection / barricade around elevator shaft to prevent entry / access of unauthorized persons to installation work area when in case of dismantle of old elevator (if applicable).
- 2) Separation of elevators from group functions by isolating completely from any power hazard and shut down of its operations before execution of dismantling jobs.
- Shifting, packing and displacing of dismantled elevator items.
- 4) Reconstruction of shaft, entrances, pit and machine rooms as per required IMEC Approved Drawings.
