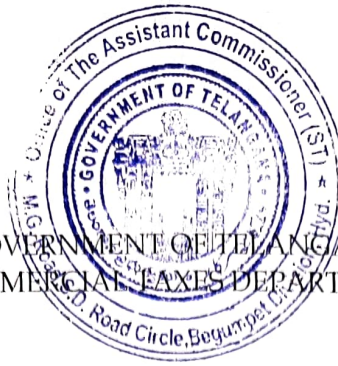

In case of failure, action as deemed fit in accordance with the provisions of Act will be taken in giving timely statutorily compliance orders to be passed on merits without any further reminder.
