- iii) Penal Interest will be charged as required the provisions of Sec.16 of the APGST Act, 1957 / Sec.22 of AP/TG VAT Act, 2005 and CST Act,1956.
- iv) Money held in other sources will be frozen as required under the provisions of Sec.17 of the APGST Act, 1957 / 29 of AP/TG VAT Act, 2005 and CST Act,1956.
