The work at Nilgiri Heights of A block is nearing completion. The flats are ready for furniture and fitouts There is a delay in installation of lifts due to shortage of workers in the industry. We are pressing the lift company for installation at the earliest. Customers who wish to occupy their flats without the lift facility may do so from 1st July, 2025.

It is difficult for us to maintain the flats in a brand new condition for weeks or months and therefore minor works like final coat of paint, polish, installing CP and sanitary ware, etc., have not been completed.

You are requested to come forward and clear all your dues (an account statement is enclosed). We shall handover possession of your flat completed in all respects within 2 weeks of clearing all dues. You shall be required to give 8 post dated cheques towards maintenance charges (payable quarterly in advance), pay the corpus fund, sign the electricity connection transfer form, sign the Nilgiri Welfare Association membership enrolment form and sign the no dues certificate at the time of clearing the dues. Upon completing these formalities we shall issue a post dated (by 2 weeks) letter of possession to enable our engineers complete your flat in all respects.

You are further requested to visit your flat and give a written list of works to be completed or complaints, if any. The same shall be attended to and completed within the 2 weeks. Our engineers have been advised to complete the minor works only after receipt of a post dated letter of possession.
