With reference to 1st cited, M/s. Granules Life Sciences Pvt. Ltd., Sy.No. 325, 326, 333, 334, 335, 336, 340, 341, 342, 343, 344, 345 and 346, Lalgadimalakpet, Shamirpet (M), Medchal – Malkajgiri District CFO Application has submitted an application seeking Consent for Operation (CFO) of the Board.

The Environmental Engineer, Regional Office, Medchal submitted verification report pertaining to the industry, vide reference 2nd cited.

The Board examined the CFO & HWA application submitted by the industry under Water and Air Acts and RO verification report. After detailed discussions, the Board recommended to issue CFO & HWA order to the industry subject to submission of the following information:

• The industry shall pay the balance consent fee including enhanced consent fee as under G.O.Ms. No. 22, dated: 09.07.2018 issued by EFS&T Dep. at TSPCB, Regional Office, Medchal and shall submit a copy of the same to this office.

In view of the above, you are directed to submit the above information within one week to this office marking a copy to the Regional Office, TSPCB, Medchal. If the industry fails to furnish the information within the stipulated time, the CFO application filed by the industry will be returned back to the industry. The industry has to again re-submit the CFO application along with complete information sought by the Board. However, the CFO fees already paid by the industry to the Board will be considered and adjusted at the time of re-submission of the CFO application.

It is also brought to your notice that operation of the industry without having valid consents of the Board is violation of Section 25/26 of Water Act and Section 21/22 of Air Act

which is punishable under section 44 of the Water (Prevention and Control of Pollution) Act, 1974 and under section 37 of the Air (Prevention and Control of Pollution) Act, 1981.
