

# Application Upgrade – complete rewrite

- Started making changes for application upgrade. Identified It is complete rewrite of the application, touching every page, every code file.
  - UI front end pages
  - Business logic layer
  - DB logic and DB schema
- It has to be executed as a full project Application upgrade.
- Can NOT be done under the regular AMC maintenance (20k per month), as it involves considerable effort/cost, and involvement of senior people.
- Combine with Phase-2 features/ enhancements (if there are any) and take it up collectively.
- Till then, we are extending the existing server (with chances of security issues) & maintain the application.
- Extended the existing server for 3 months, Feb, Mar, April. Paid by the Chidhagni team.

# Team - Rebuild with renewed commitments

- The costs of running team has increased multiple times.. From 2019 to 2025. in the last 6 years.
- Major revision happened during the covid time, 2020-22. The costs have really gone up manifold.
- Successfully retained the team, ran the project execution with full 100% application availability
- With 12LPA expense for the 2-member team, We couldn't afford to continue running the team at huge loss. We let 1-team member
- At the project level, Team suffered huge losses for multiple reasons & we cannot afford to do the same at the current cost burn rate.
- We will rebuild the team again only with the commitment for Phase-2 (Application upgrade) of the project & with cashflow, payments

# Value – Significant value addition to the MPPL group

- There is significant value added via the digital transformation initiative of m-codex.
- There is 3-4X features added to the m-codex application drawing from the industry wide applications, compared to the old system that was sunset.
- · Certain modules became indispensable.
  - Document management system
  - CRM, Post sales.
  - Purchase system
  - Billing system.
- · Reduced expenses in resource time, and making some positions redundant Reduced staffing needs
- · Brought tremendous cost savings to the MPPL group operations.
- · Improved overall efficiency.

# Costs to Chidhagni - P&L

- Incurred People costs = ~18LPA for first 2 years., and 10LPA for next 4 years. From 2019 April to 2025 Mar.
- · That's 76+L people costs.
- Including a nominal costs (~6LPA) as a leader running the technology initiative for last 6 years.. The overall costs are ^ 110L+

#### Some drivers for the costs

- Team included every change (Scope creep) & changed requirements multiple times (as many times as needed).
  - All new requirements are included (whether they are in old system or not) with full conviction to make the application successful.
  - · Requirements are updated/changed multiple times.
  - Ex Purchase system took 1+ year > developments, requirements, review, changes, that cycle went on.
- We did this, for the benefit of the MPPL team, but at the cost of Chidhagni.

# Costs to Chidhagni - P&L

- Received ~19L for Software development (against the expenses incurred given in earlier slide)
- · Below are the payments received from MPPL After July 2021 , we didn't take any for the New Development works.
- Every time, it is part payments received.. Straining the Chidhagni operations multiple times.

We pulled it off by putting in money from other sources, projects.


