1.The approval for the project was received in 2019. The approval was revised in 2021. Due to the Covid pandemic which lasted for over a year and half from March, 2020, the construction and sales of the project were adversely affected. Even after the Covid pandemic, availability of material was adversely affected. 2. The project is by and large completed. 8 blocks of flats, clubhouse block are fully completed including provision of power supply, power back-up, lifts, water, drainage, etc. Possession to 155 customers has been handed over since 2022. Common amenities like children park, driveways, parking, utilities, STP, common area lighting, gates, compound wall, security kiosk, etc., are also fully completed. 3. Application for occupancy certificate was first made on 03.02.2023. Due to technical issues the occupancy certificate has not been issued. We have re-applied for occupancy certificate on 03.02.2024 again due to technical issues the occupancy certificate has not been issued and again re-submitted on

23.06.2025 and it is under process. 4. Only minor works related to 3 tot-lots in the middle of the layout are pending. These are likely to be completed in 4 to 8 weeks time. The minor work does not adversely affect the enjoyment of the flats purchased by prospective purchasers. 5. Accordingly, we are requesting for an extension of the RERA registration for one year.
