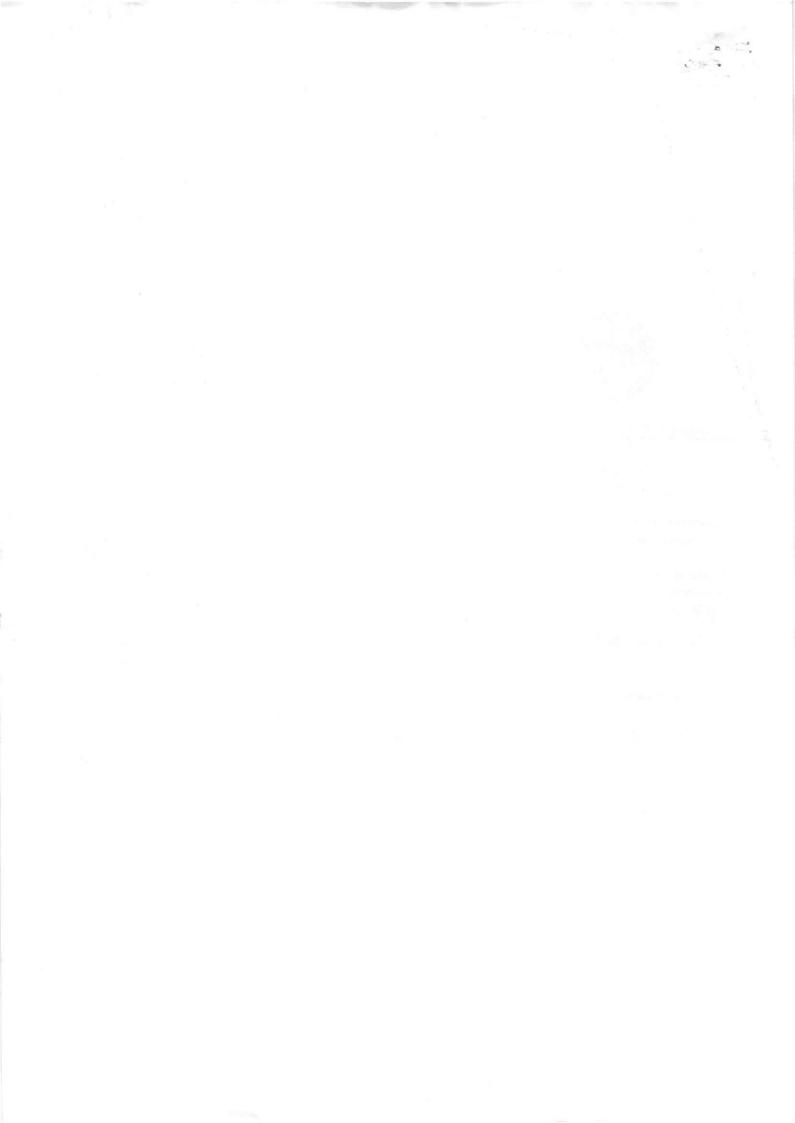

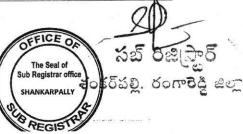

WHEREAS:

- 7. The Developer upon completion of construction on the Scheduled Property, shall intimate the Buyer about the same at his/her last known address and the Buyer shall be obliged to take possession thereof, subject to the condition that he/she has fulfilled all his/her obligations * including payment of the entire consideration hereunder according to the terms hereof strictly.
