I am aware of the terms and conditions laid down in the MOU with respect to maintaining the high standards of living in the said project.

I am aware that the clubhouse is under the management of M/s. Serene Clubs & Resorts LLP. We agree to pay the monthly maintenance charges regularly to M/s. Serene Clubs & resorts LLP for these services from May-21. (Monthly maintenance charge for period ____ to ____ have been waived).

I also certify that these conditions shall be imposed on my successors-in-interest.

1. Monthly maintenance charges payable to Serene Clubs & Resorts LLP.
 - a. Calendar year 2020 – Rs. 3,500/- per month (Rs. 5,000/- per month).
 - b. Calendar year 2021 – Rs. 3,800/- per month (Rs. 5,500/- per month).
 - c. Calendar year 2022 – Rs. 4,100/- per month (Rs. 6,000/- per month).
 - d. Calendar year 2023 – Rs. 4,400/- per month (Rs. 6,500/- per month).
 - e. Calendar year 2024 – Rs. 4,400/- per month with an annual increase of between 5% to 10%. (Rs. 6,500/- per month).
2. This amount shall be payable to Serene Clubs & Resorts LLP in advance every month before 5th of each month. Any default in payment may result in:
 - a. Discontinuation of water supply.
 - b. Customer shall be barred from using clubhouse.
 - c. Disconnection of generator backup and/or electric power connection.
 - d. Once dues are paid, reconnection charges of Rs. 5,000/- will be levied.
3. GST shall be payable extra, if applicable.
4. Services provided shall include:
 - a. Security services
 - b. Housekeeping services for common areas
 - c. Housekeeping services – once a week for villa/cottage.
 - d. Maintenance and upkeep of clubhouse

5. Additional charges shall be payable for:
- a. Repairs and maintenance of villa & farmland.
 - b. Use of clubhouse for get togethers.
 - c. Use of cottages for guests.
 - d. Food and beverages shall be provided from nearby vendors on actuals.
 - e. Additional monetary services.
