The final decision in this matter shall be at the discretion of Modi Properties and claims shall not be made on this count.
- 9. A sum of Rs. 10,000/- shall be paid to you, within 7 days of the customer signing the agreement of sale. The balance brokerage shall be paid to you (after deducting TDS + GST), within 15 days of receiving 40% of total sale consideration from the customer for their flat /villa.

You shall endeavor to extend this understanding 7 days prior to its expiry by signing a letter of extension for the extended period.
