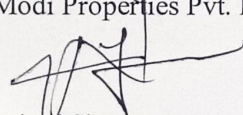
1. You shall be permitted to promote the said projects amongst your customers, business associates, etc.

4. You shall not offer any discount to prospective customers. The discussion on discount will be handled by our sales team. Your primary target is to bring the customer to our site.
5. Our sales team will handle the customer after your introduction of the customer to our sales team.
6. For all customers introduced by you brokerage at the rate of 2% on the net sale consideration shall be paid to you.
