- 2. You shall inform the customer that you are representing Modi Properties as an authorized Channel Partner (you cannot claim to be an employee / partner/ business associate).
- 3. You shall send leads to us through our website, www.modiproperties.com. Click the link 'Chanel Partners' at the bottom of the homepage. Login by selecting your name. your password is your mobile number. Enter the details of your customer. You will receive a confirmation email with details of customers.



- 4. You shall not offer any discount to prospective customers. The discussion on discount will be handled by our sales team. Your primary target is to bring the customer to our site.
- Our sales team will handle the customer after your introduction of the customer to our sales team.
- 6. For all customers introduced by you brokerage at the rate of 2% on the net sale consideration shall be paid to you. The final decision in this matter shall be at the discretion of Modi Properties and claims shall not be made on this count.
