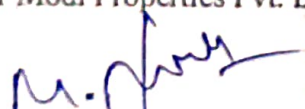
1. You shall be permitted to promote the said projects amongst your customers, business associates, etc.

4. You shall not offer any discount to prospective customers. The discussion on discount will be handled by our sales team. Your primary target is to bring the customer to our site.
5. Our sales team will handle the customer after your introduction of the customer to our sales team.
6. For all customers introduced by you brokerage at the rate of 2% on the net sale consideration shall be paid to you. 7. Brokerage shall be paid for customers introduced by you only if the sale is closed within 3 months from date of introduction of the prospective customer.
8. Customers who have contacted us prior to intimation by you as given above, shall be deemed to be customers of Modi Properties and brokerage for such customers shall not be payable. The final decision in this matter shall be at the discretion of Modi Properties and claims shall not be made on this count.
