1. Any statutory duties and taxes levied by the government retrospectively will be charged extra at the time of final billing.

2. This price proposal is made based on the architectural drawings / dimensions provided to us. Quotation is given on the present prices subjective to change.

3. The profiles considered are white

4. The Glass will be used HNG/Modiguard/Saint-Gobain or equalant.

5. The Cheque / DD has to be drawn in favour of Vibrant Facades LLP

6. Supply Schedule to be strictly at par with payemnt schedule

Payment Terms

(a) 50 % of Purcahse Order Value as Advance along with Purcahse Order

(b) 40 % of Purcahse Order Value on delivery of Materials

(C) 10 % of Purcahse Order Value after completion

7. Work Schedule will be at part with the payment schedule.

8. RA Bills : RA Bills will be raised & submit by 10 th of each calender month, The same to be certified by your ite within 7 days. After which the tax invoice will be submitted as per the certification. The payment for the Tax Invoice to be made through A/c Payee cheque within 7 days from the date of submission.

9. Lead time: Windows delivery within 21 days from the date of site survey and receipt of advance. Installation will start after delivery of material , with the following conditions:

a) The temporary power point to be provided at site on each floor. The power to be supplied at free of cost. The lighting required for the fabrication to be provided.

b) Wall should be plastered/ painted from inside and outside.

c) Flooring to be completed where doors have to be installed

d) Aperture to be smooth

e) Base and top of windows to be water leveled and sides should be in vertical plumb.

f) Sill width to be more than window width.

g) Scaffoldings / Bracing should not interrupt the window openings where windows are supposed to be installed.

h) Openings should be accessible from inside for installation.

i) Grills should be fitted after complete installation of window(incl mesh)

j) Necessary Scaffolding to be provided by the builder wherever required

j) Installation will be done flat, floor & block wise only.

k) Plumbing and Flooring level to be ensured. Any civil defects to be rectified. Sealing of gaps between the masonry structure and uPVC frames will be builders responsibility, However a gap upto 3 mm is acceptable and the same will be filled by silicon sealant.
