



1. All Doors/ Windows are manufactured as per the drawings approved by the Client at the time of Order Confirmation.
2. Customized Sizes are manufactured with additional charges and its acceptance is subject to approval.
3. Changes in drawing cannot be accepted once the order is into production. If required, it can be treated as new order.
4. Order cancellation/Sizes amendment cannot be accepted post drawing approval by the Client and no refund can be made.
5. Aaccess will ensure proper packing of doors as per.
6. Aaccess Tough Doors would not be responsible for the Transport and any transport damages.
7. Payment terms: 50% advance with PO, 50% on Inspection and Before Delivery of material from our works.
8. Dispatch of materials: 1 month from the date of complete technical and commercial acceptance from the Client.
9. Warranty: AACCESS TOUGH DOORS PVT LTD. warrants its manufacturing, materials.
10. Installation defects for normal usage of doors for a period of 18 months from the date of dispatch.
11. Cancellation of order: In the event of cancellation of order after payment of advance, the advance paid shall be forfeited without any Notice and shall not be refunded.
12. Force Majeure: Shall be applicable to cover the events such as natural calamities, strikes, lockouts, etc., and any other conditions beyond our control.
13. Neither Party will be liable for any failure or delay in performing an obligation under this Agreement due to Force Majeure events.
14. In the case of delay caused due to Force Majeure and if the price of the raw material is changed, the difference amount shall be charged from the client.
15. The Parties acknowledge future impacts of Covid-19 as unforeseeable and consider it a Force Majeure event.
16. Idle Charges: If wall openings are not ready, idle charges @ 800/- per day per team will apply.
17. Wall openings (inspection of wall fronts): Requisite wall openings will be checked as per approved drawings.
18. Installation Stages:
 - a) Shift doors to the point of installation.
 - b) Complete finishing between door frames and wall openings by site personnel at client cost.
19. Site readiness: Mobilization occurs if 30% of wall openings are ready initially and 20 door openings are available continuously.
20. Security: Once installed and handed over, responsibility lies with the client.
21. Disputes: All disputes shall be subject to the jurisdiction of Secunderabad / Hyderabad courts only.
22. Technical Clearances Required:
 - Drawings approval
 - Color approval
 - Orientation approval
 - Accessories samples approval.
23. Commercial Clearances Required:
 - Quotation acceptance
 - PO acceptance and confirmation
 - Advance payment via RTGS/NEFT.
