LESSORS and LESSEE shall, wherever the context may hereinafter so require, be collectively referred to as 'Parties' and individually as 'Party', as the case may be.

## WHEREAS:

- 1. At the expiry of this period, this lease may be renewed as may be agreed between the Parties.
- 2. The LESSEE shall pay the monthly rent of Rs.21,160/- (Rupees Twenty one thousand one hundred and sixty only) as mutually agreed in the clause no.1 of the Lease Deed dated 6<sup>th</sup> September, 2013 for the entire duration of extension made vide this Supplemental Agreement.
- 3. The LESSORS shall retain a sum of Rs.2,40,000/- (Rupees Two lakh forty thousand only) which has been paid by LESSEE towards security deposit as per Lease Deed dated 6<sup>th</sup> September, 2013, during the extended period also and the LESSORS shall refund the security deposit without interest to the LESSEE upon the end of the extended lease period or earlier termination thereof.
