We have obtained building permission vide DPMS File No. 021601/MED/R1/U6/HMDA/15032019 to construction residential apartments in the land bearing Plot Nos. 22/P, 23, 24, 35, 36 & Plot No. 37/P admeasuring 1,122 Sq.yds forming part of Sy. Nos. 1, 16, 17 & 19/1 situated at Muraharipally Village, Yadaram Grampanchayat, Shamirpet Mandal, Medchal Malkajgiri District, Telangana.

At the time of submission of building permission application we have not submitted NOC from Revenue authorities i.e., NALA conversion proceedings. 
