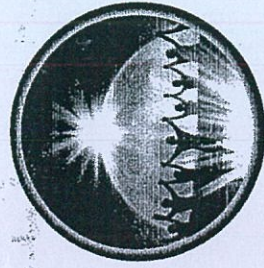

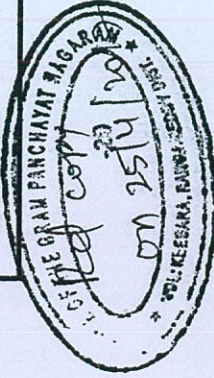

Sir/Madam

On behalf of the residents of our colony and the neighbouring colonies (Sri Sai Shukla & Shilpa Nagar), we would like to bring to your kind notice the problems, health & environmental hazards that we are facing by the nearby construction site of M/s Paramount Estates, Nagaram. Our complaint is against this construction site requesting your immediate attention and rectification causing health and environmental hazards to the residents. The below mentioned issues need immediate attentions and related favourable actions.

1. The colony roads are totally damaged due to their construction material's heavy vehicular movement; all these roads needs immediate repair and future maintenance.
2. The main entrance road from Serenity School towards Sangamithra Enclave through Shilpa Nagar colony is highly damaged. The road too requires proper repair and maintenance.
3. The sewage is being continuously dumped in to the adjacent open land as they do not have any permanent drainage outlet which is causing foul smell and increase in harmful mosquitoes leading to serious health problems. The sewer line needs proper disposal through covered pipelines. The present pumping of sewage should be stopped immediately.



4. The dust generated from construction site, flying all over the colonies have led to serious health issues; especially to the olds, small children and those who are having Asthamas. It has become difficult to breath due to the pollution caused by the site. Proper protective covering to the construction site we request so that no dust is flown out to the nearby area.

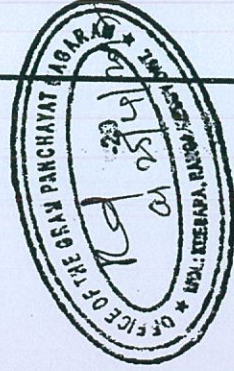
5. The debris from construction site is dumped in the common open drainage (Nala) and the open land to the south side of the site. Because of this dumped debris, it is blocking the main drainage system.

6. There is neither proper water harvest system neither any water recycling system. Instead they have heavy machineries pumping out ground water. This has drastically depleted the ground water level in our area. They should take proper responsibility in increasing and helping to preserve our Natural water resources.

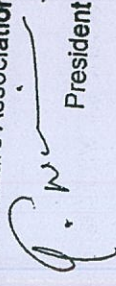
All the above issues need urgent and proper solutions with you kind attention and necessary actions.
