Soham Modi S/o Late Satish Modi is hereby permitted to cut down (01) Toddy tree located in Sy no. 82/1 (P), Mallapur(V), Uppal(M), Medchal - Malkajgiri District which are objecting in construction of Residential Apartments subject to the following conditions under Sub.Rule. (5) Form. No. 11(a) of Rule 24 of A.P. Water, Land & Trees Rules, 2002 namely and Under Section 27 of A.P.Excise Act 1968.

1. Premises of felling tree/trees is as mentioned above only
2. Number of tree/trees permitted to be felled is (01) Toddy tree only
3. (05) plants shall be planted within (30) days at a suitable place.
4. In case of failure to take up plantation, plants shall be raised at the cost of the applicant.
