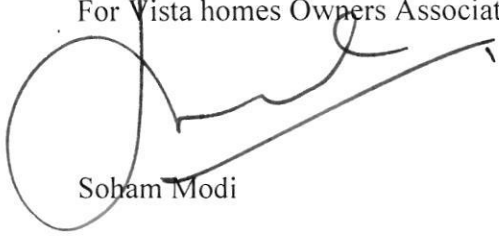

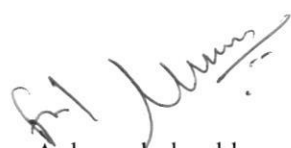

- 1.5 This agreement does not give rise to any liability or obligation to RMCL and the successful application, operation and the management of the equipment shall be the responsibility of the customer only.
- 1.6 This agreement covers only the maintenance problems arising out of normal functioning of the machine and does not cover the service of breakdown arising out of misuse of the machine or its use under environmental conditions not prescribed by RMCL, due to shifting/transporting of the machine from original place of installation or due to faulty functioning of other system/subsystem which has been interfaced with the equipment specified in this contract.
- 1.7 On termination of this contract, RMCL obligations under this agreement cease in its entirety. The customer may enter into a fresh contract with RMCL if RMCL satisfies itself that the machine is in a maintainable state. All costs of inspection, time and material to bring the machine to a maintainable state will be charged by RMCL to the customer.

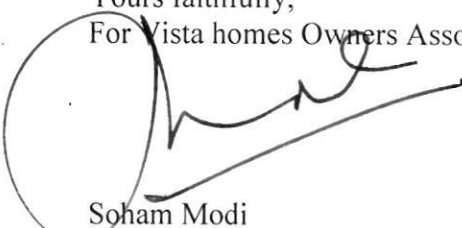

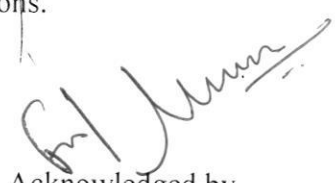
