Sub: NE- Waste water and neibhour's objection.

This has reference to the above subject matter, I visited NE yesterday and discussed the matter with Mr.Madhusudhan.

The excess and overflowing waste water is presently being pumped into the southern side of our neibhour who is presently objecting.

Upon your advise the following options shall be discussed with the neibhour(s).

1. On verifying the real owner, some compensation may be decided either in total or on monthly basis.
2. Laying a pipeline from our site to the canal which is about 300 to 400 meters. Measurement will be taken. Even for laying the pipeline we need
to take permission from the neibhour(s).
3. Presently there are about 40 occupants only at our site and many more to occupy.
4. If the neibhour do not agree for any compensation, the same may be negotiated through the Sarpanch.
5. Any other alternative you may kindly advice.

Further action shall be taken as per your directives.
