1. Inspection undertaken

The service connection bearing No. 2016 01076 ,Category LT II(B)-Non Domestic/Commercial-Above 50 Units/Month, Village/ Section KEESARA was inspected on 08-Nov-16 at 14:15 hours by Sri. A.BABU RAO designation AAE . A copy of the Inspection Report was handed over to the consumer / his representative on 08-Nov-16.

2. The following incriminating points are observed from the Inspection Report:

At the time inspection bearing SC.No. 2016-1076 which is belongs to M/s Modi & Modi construction under LT cat-II with contracted load of 4kw on analysis of the load since for the release of the supply for commercial use it is found that consumer utilizing for the load of 12.77kw and hence additional load of 8.77kw proposed for development charges and difference of KVAH to KWH reading from 12.05.2016 to 08.11.2016 i.e.. (8100-6936)=1164 units are proposed for short billing, short billing is proposed.

3. Nature of defect reported

The above observations clearly establish that the meter installed at your service connection is not functioning correctly. The MRT report reveals that the meter was recording less energy consumption. Hence Short billing was done for your service owing to defective meter.

4. Charges payable to the Company for SHORTBILLING-UNBILLED SERVICE

On careful consideration of all the relevant aspects, I have provisionally assessed the electricity charges due to the Company as per clause 7.5.1 of the General Terms and Conditions of Supply at Rs 9140.0. The calculation sheets for the same are enclosed for your reference.

5. Future Course of Action

If you wish continuance of supply, you may pay Rs. 4570.0 (Rupees Four Thousand Five Hundred Seventy) being 50% of the provisionally assessed amount + Incidental charges of Rs. 0 to the AAO/ERO HABSIGUDA (designated officer for payment of assessed amount), and furnish receipt to me within 7 days from the date of service of this order.

If you are agreeable to the assessed amount, you may pay the amount in full within 15 days from the date of service of this order. Further proceedings to recover the assessed amount will be closed after production of a receipt towards payment of the provisionally assessed amount of Rs 9140.0 in full, to AAO/ERO HABSIGUDA (designated officer for payment of assessed amount), in addition to the Incidental charges of Rs.null and the reconnection charges of Rs.null

.. If you are not agreeable to the above assessment, you may make a representation to Divisional Engineer/Operation/HABSIGUDA within 15 days from the date of service of this order. You may also specifically indicate in your representation whether you want to be heard in person.
