- B. The Schedule Property is the ancestral property of the Vendors. Vendors 1 to 5 are entitled to equal shares in the Schedule property and they are in joint possession of the Schedule Property. 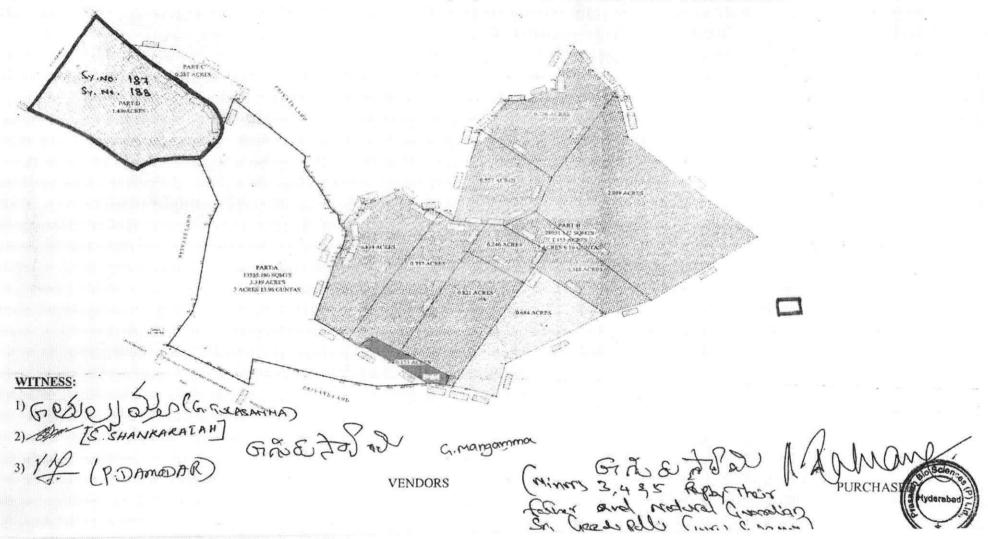
