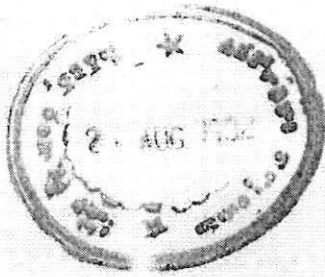

NOW THIS DEED OF SALE WITNESSES AS FOLLOWS:

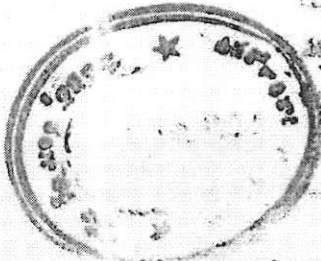
