2. **RESOLVED THAT** the drafts of the Loan Documents are hereby approved and the consent of the Board of the Company be and is hereby granted to the Company, to accept and execute the Loan Documents.
3. **RESOLVED THAT** the consent of the Board of the Company be and is hereby granted to the Company, to execute all such documents, undertakings, and confirmations as may be required by BHFL in relation to the Loan.
4. **RESOLVED THAT** the Board authorizes **Mr. Soham Satish Modi or Mrs. Tejal Modi**, jointly/severally, to *inter alia*, to negotiate, discuss, settle, finalize and accept the terms and conditions of the Loan, sign/execute applications/documents/agreements in connection with the Loan as stipulated by BHFL in the name and on behalf of the Company as Authorised Signatories, provided that if any such documents / agreements are to be signed under the common seal of the Company, the same be affixed as per the provisions of the Articles of Association of the Company and to take such further action as may be necessary in this behalf.
