

Our team has been appraised about your discussion with our MD in the presence of our engineers Mr. Zakir and Mr. Sridhar. Your chief complaints about improving the frequency and infrastructure for curing and careful implementations of additions and alterations requested by you have been noted.

Immediate steps for improving the frequency and infrastructure for curing have been taken. Additional manpower for supervision and curing has been provided. We already have 4 borewells at site for curing. The pipelines for inter-connecting all the borewells has deteriorated. We are replacing all the pipes. We hope to have a better infrastructure for curing within 2 weeks. Till such time 4 additional pumps have already been deployed at site.

We have asked our senior project manager, Mr. Sridhar.A, to personally review additions and alterations specified by our customers and ensure that the additions and alterations are made appropriately at each stage of construction. Our quality control team has also been advised to doubly check the additions and alterations before permitting the engineers at site to proceed to the next stage of construction. They will ensure that our site engineer is present in the meeting for assistance related to construction related activities.

We acknowledge that you have made payment of installments without ant delay. We are in the process of scheduling the work of each villa and the common amenities. The date of completion of your villa will be communicated to you shortly.
