

The terms Donors and Donee shall mean and include wherever the context may so require their heirs, legal representatives, executors, administrators, successors in interest and assigns.

WHEREAS:

- A. Whereas Samala Ramaiah, Samala Rajamallaiah, Samala Narsaiah, Samala Veeraiah and Samala Yellaiah were the original pattedars of land forming Sy. Nos. 97 and 98 of Annoiguda Village, Pocharam Municipality, Ghatkesar Mandal, Medchal-Malkajgiri District, Telangana. Their names were appropriately reflected in the revenue records. Hereinafter the pattedars along with their legal heirs are referred to as the Original Pattedars.
- B. The Original Pattedars sold land admeasuring Ac. 5-05 gts., in Sy. No. 97 & 98 to Gorakhnath, Natharam and Vijay Kumar by way of registered sale deed (detailed in Sl. No. 1 of Anx –A).
- C. Gorakhnath, Natharam and Vijay Kumar obtained a permit for sub-dividing the land into several plots from Pocharam Grampanchayat. The plots were numbered as plot nos. 95 to 185.
- D. Gorakhnath and Vijay Kumar executed a registered General Power of Attorney to sell their share of land in favour of Natharam (detailed in Sl. No. 2 of Anx –A).
- E. Natharam representing himself as GPA holder gifted the entire land to his daughters viz., Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan, the Donors herein, by way of registered gift deed (detailed in Sl. No. 3 of Anx –A).
- F. Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan executed a registered General Power of Attorney for selling parts of the land in favour of their father Natharam (detailed in Sl. No. 4 of Anx –A).
- G. Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan represented by their GPA holder Natharam sold plot no. 113 admeasuring 200 sq. yds, to Abishek Garg by way of registered sale deed (detailed in Sl. No. 5 of Anx –A).
- H. Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan represented by their GPA holder Natharam sold plot no. 114 admeasuring 200 sq. yds, to late Ankur Garg (a minor) by way of registered sale deed (detailed in Sl. No. 6 of Anx –A). After his death, the plot devolved to his father Mr. Suresh Agarwal.

Mrs. Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan represented by their GPA holder Natharam sold plot no. 147 admeasuring 200 sq. yds, to Naresh Kumar Bhatt by way of registered sale deed (detailed in Sl. No. 7 of Anx –A). Naresh Kumar Bhatt in turn sold the plot to Ashish Wadhawan by way of registered sale deed (detailed in Sl. No. 8 of Anx –A).
- J. Mrs. Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan represented by their GPA holder Natharam sold plot no. 183, 184 & 185 admeasuring 1,000 sq. yds, to G. Srihari & G. Latha by way of registered sale deed (detailed in Sl. No. 9 of Anx –A).
- K. Mrs. Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan represented by their GPA holder Natharam sold plot no. 174, 175, 176 & 177 admeasuring 1,060 sq. yds, to G. Srihari & G. Latha by way of registered sale deed (detailed in Sl. No. 10 of Anx –A).
- L. Mrs. Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan represented by their GPA holder Natharam sold plot no. 117 & 118 admeasuring 400 sq. yds, to Rampal Jaju by way of registered sale deed (detailed in Sl. No. 11 of Anx –A). Rampal Jaju in turn sold the land to B. Satti Reddy and K. M. Reddy by way of registered sale deed (detailed in Sl. No. 12 of Anx –A).
- M. Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan gifted 74 plots bearing nos. 95 to 112, 115, 116, 119 to 146, 148 to 173 admeasuring 15,040 sq. yds, to Asish Wadhawan by way of registered gift deed (detailed in Sl. No. 13 of Anx –A).
- N. Plot Nos. 178 to 182, admeasuring 1,060 sq.yds, were sold to third parties by Suman Wadhawan, Varsha Rani Wadhawan and Rajani Wadhawan.
- O. The total land admeasuring Ac. 5-05 gts., less 1,060 sq. yd, i.e., 23,745 sq yds is co-owned by several owners, referred to above, and the said land is hereinafter referred to as the Total Land.
- P. Accordingly, the ownership of the Total Land is as follows:
 - i. Mr. Ashish Wadhawan owns 15,240 sq yds of land.
 - ii. The Donors own 2/3rd share of 5,645 sq yds of land, being the residual part of the Total Land.

The Donors and Suman Wadhawan represented by their father Mr. Natharam and GPA holder (GPA document no. 556/Bk-IV/91) along with the Donee and other co-owners had executed a Development Agreement cum GPA (JDA) in favour of M/s. Satyavani Homes JV for land admeasuring Ac. 5-05 gts., forming a part of Sy. Nos. 97 & 98 of Annojiguda Village, which was registered as document no. 13581/06 dated 24-08-2006 registered at SRO Ghatkesar. In pursuance of the JDA M/s. Satyavani Homes JV made an application for building permit for a larger piece of land admeasuring Ac. 10-07 gts.

- R. By way of letter no. 105590/P4/Plg/HMDA/2013 dated 16-04-2014, HMDA has approved building permit for a larger piece of land admeasuring Ac. 10-07 gts., forming a part of Sy. Nos. 97 & 98 of Annojiguda. Building permit was granted for 2 blocks consisting of 2 basements + stilt + 5 upper floors. The Donee herein was one of the co-owners of the land that formed a part of the larger piece of land. Due to unavoidable circumstances the project is stalled.
- S. The Donors have agreed to transfer by way of this gift deed the residual land appurtenant to the layout being 2/3rd share in land admeasuring 5,645 sq. yds, to the Donee herein. The 2/3rd share of land admeasuring 5,645 sq yds forming a part of Survey Nos. 97 & 98, situated at Annojiguda Village, under Pocharam Gram Panchayat, Ghatkesar Revenue Mandal, Medchal-Malkajgiri District, Telangana State is hereinafter referred to as Scheduled Land and more fully described at the foot of this document.
- T. The Donors out of natural love and affection which they have towards their brother, the Donee herein have transferred all their residual interest in the Total Land, i.e., 2/3rd share in the land admeasuring 3,763 sq. yds, out of 5,645 sq. yds, (Scheduled Land) to the Donee herein by way of absolute and irrevocable gift.

- 2. The Donors hereby confirm that they are absolute owners of Scheduled Land and are entitled to transfer the same to the Donee herein.
- 3. The Donors hereby covenant that they shall sign, verify and execute such further documents as are required so as to effectively transfer their rights on the Scheduled Land in favour of the Donee in the concerned departments.
- 4. That the Donee has duly accepted the above said gift and in the aforesaid manner.
- 5. The Donors confirm that they have hereby transferred all their right, title and interest, in Scheduled Land, to the Donee herein and that they have no further right, title, claim of whatsoever nature on the Total Land.




