G. Road, Secunderabad — 500 003, represented by its Managing Director Shri. Soham Modi S/o. Late Shri. Satish Modi aged 49 years, Occupation: Business, resident of Plot No. 280, Road No. 25, Jubilee Hills, Hyderabad — 500 034 hereinafter referred to as the BUILDER

The expression 'Owners' and Builder' shall mean and include unless it is repugnant to the context, their representative heirs, legal representatives, administrators, executors, successors in interest, assignees, nominees and the like.

WHEREAS:

- A. The Owners are the absolute Owners and possessors and in peaceful enjoyment of land in Sy. 196 (P) situated at Kaukoor Village, Malkazgiri Mandal, GHMC Alwal Circle, Medchal District, Telangana admeasuring Ac.2-00 gts.

- E. The parties are recording the terms of their agreement in to writing.

THIS DEED OF AGREEMENT FOR OWNERS' AND BUILDERS CONTRACT WITNESSES AS FOLLOWS:

- 1. That the parties hereto have mutually agreed to cancel the Owners' and Builders' Contract Agreement dated 23rd March 2019 registered as document No.71/N/2019 at the SRO, Malkazgiri, Medchal District in respect of rendering of consultancy services in construction of residential apartments in the above said land admeasuring Ac.2-00 gts in Sy. No. 196 (P), situated at Kawkoor Village, Malkazgiri Mandal, Medchal District, Telangana.
- 2. That the Owners and Builder hereto hereby declare and covenant that they have no rights or claims of whatsoever nature against each other. The Owners have not paid any amount to the Builder towards consultancy charges and the Builder have not rendered any consultancy services in respect of the construction of residential apartments on the above said land.
