On the personal hearing referred to above the following was discussed:

- 1. The Developer i.e., M/s. Kadakia and Modi Housing was asked to ensure that the utility services like water supply, drainage and streetlights were provided in the said housing project viz., Bloomdale, Shamirpet.
- 2. The complainants were asked to send a reply to the representations given by us to HMDA along with photographs showing details of amenities and facilities provided in the housing
- We were only informed that the next hearing would be on 19th December, 2020.

In response to the above please note the following:

- The utility services mentioned above have been provided since 2013. The proof of provision of the said services is as follows:
 - a. Water supply through water board copy of latest bill is enclosed.
 - b. Water supply through borewell 4 borewells have been made and connected to the common water supply – pictures of the 4 borewells are attached.
 - c. Drinking water supply through RO plant RO plant photo is attached.
 - d. Water supply through overhead tank photograph of OHT is attached.
 - e. Drainage connection each villa has been separately connected to the main drainage line and a manhole has been provided for each villa (3 sample photos are attached). The treated water from septic tank is connected to public drainage line (photo of drainage chamber on street is attached).
 - f. Streetlights few years ago streetlights of 6 mtrs height with 1 mtr arm were provided in the project. However, the light was being obstructed by the trees planted on the roads. To correct the situation the streetlights were replaced with 6 streetlights with a 3mtr arm and 2 nos 100W LEDs (photographs enclosed). These lights are satisfactorily providing lighting at night for the last couple of years. 2 nos additional streetlights have also been provided.
 - We are awaiting further communication from the complainants in reply to our letters given to HMDA.

In light of the above you are requested to postpone the personal hearing to a suitable date after Pongal in January, 2021.




