Sub: Reply to letter dated 19-08-2020 – "Difference between GSTR 3B and GSTR 9C"- DIN: 20200856YO00005C135E

We are in receipt of your letter dated 19-08-2020, seeking clarification on difference in turnover between GSTR -3B and GSTR -9C. We would like to submit the following for your kind consideration.

Point no 1 of the said letter is reproduced below for ready reference

- a) The turnover declared in GSTR-9C for the year 2017-18 is not tallied with Outward supplies as per GSTR-3B.

- b) In the letter, turnover as per Balance Sheet for the year 2017-18 is considered as Rs 13,02,44,291/-. We hereby submit that the said amount is incorrect. It appears that opening balance of Capital Account is incorrectly considered as turnover in your letter. The correct turnover for the FY 2017-18 as per financials is Rs 2,78,67,853/- Please find the enclosed the financials of FY 17-18 for your ready reference as Annexure-1.

- c) Considering the correct turnover for FY 2017-18 as Rs 2,78,67,853/- the revised comparative table will be as below:

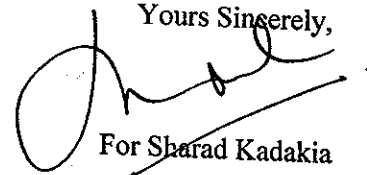
- f) It may be noted that as per financial statement, the taxable turnover as reconciled in GSTR 9C (Table 7F) is Rs 2,08,88,182/- However the taxable turnover declared in GSTR 3B for the relevant period is Rs 2,11,55,174/-. As per above, it is hereby submitted that turnover of Rs 2,66,992/- was excess declared in GSTR 3B erroneously.
- g) As requested in the letter, we hereby submit GSTR 3B for July 2017-18, ITR (Complete Set) and Profit and Loss (Along with Financial Statement), 26AS for Financial Year 2017-18.
- h) It may be noted that information is also sought for year 2014-15 to 2016-17. Since our turnover is reconciled and there is no apparent difference, the said information requested is irrelevant for reconciliation of GSTR 3B and GSTR 9C for FY 2017-18. Therefore, we are not submitting the same. Hope you find the above submission in order.

On comparison between GSTR3B and GSTR9C, the following discrepancies were observed.

1. The turnover declared in GSTR 9C for the year 2017-18 is not tallied with Outward supplies as per GSTR3B.

From the above, it is not clear actual turnover done by you during the said year. Hence unable to reconcile with the documents uploaded. Therefore you are requested to clarify the same along with documentary evidence i.e. Service tax returns, ITR (complete set) and P&L a/c filed before the Income Tax, 26AS and 26Q from 2014-15 to 2017-18.

The compliance may be submitted at the earliest.

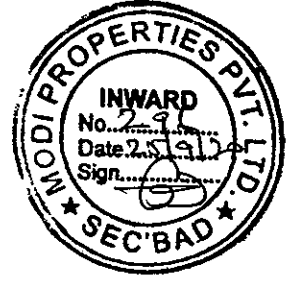

Subject: Difference between GSTR3B and GSTR9C-reg.

Please refer to this office letter of even no. dtd. 21.08.2020 wherein you were requested to submit the documents i.e. ST-3 returns, ITR (Complete Set), 26AS, 26Q and Balance Sheet along with Profit & Loss a/c filed before the Income Tax dept. for the period from 2014-2015 to 2017-18 but you have provided the said documents for the period 2017-18 only and you have not provided ITR Form (with complete set) for the F.Y 2017-18. Instead of ITR 5/3 (with complete set) this office received Financial Statement which is incorrect.

Non-submission of complete documents for the said period in this office even after passing of more than 25 days implies that there is intentional and inordinate delay in submission of documents.

In view of the above, you are once again requested to submit the following documents covering the period from 2015-16 to 2017-18 immediately via mail or speed post.

1. Balance Sheet with P&L a/c as declared before the Income Tax Department.
2. ITR - 3/5 Form (with complete set i.e. without missing a single page)
3. 26AS.
4. ST-3 returns along with duty paid challans.
5. Taxable invoices
6. Documents pertaining pure agent if applicable.
7. All rental agreements.

The documents are required for the period from 2015-16 to 2017-18 (April to June) because certain discrepancies have been noticed. If the above said documents are supplied then in detail scrutiny can be taken up. If any short payment of Service tax is noticed, you are required to pay tax along with interest failing which a Shown Cause Notice has to be issued.

Supply of incorrect data, false information and documents will invite penal provision as per Finance Act, 1994.

If the said documents are not supplied within three days, '**SUMMONS**' will be issued with due permission from the Deputy commissioner as per the Finance Act, 1994.
