The Environmental Engineer, Regional Office, Medchal-Malkajgiri District has forwarded the CFE application through TS-iPASS of M/s. Dr. N.R.K. Bio-Tech Private Ltd., Plot No. 11, Part of Sy.No's. 230 to 243, Shapoorji Pallonji Bio-Tech Park, Phase-I, Kolthur (V), Shamirpet (M), Medchal-Malkajgiri District along with verification report to the Zonal Office, Hyderabad, vide reference 2nd cited.

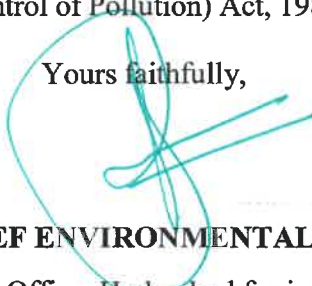
The Consent for Establishment in the meeting held on 25.08.2021 examined the CFE application submitted by the industry under Water and Air Acts. After detailed discussions, the committee recommended to issue CFE to the industry on submission of the following information:

- ***The facility shall submit undertaking on a Rs.100/- Stamp paper stating the facility shall not lease the premises to manufacture drugs & Pharmaceuticals in pilot plant as the same will attract provisions of EIA notification, 2006.***

In view of the above, you are directed to submit the above information within 15 days to this office marking a copy to the Regional Office, Medchal-Malkajgiri District. If the industry fails to furnish the information within the stipulated time, the CFE applications filed by the industry will be returned back to the industry. The industry has to again re-submit the CFE application along with complete information sought by the Board. However, the CFE fee already paid by the industry to the Board will be considered and adjusted at the time of re-submission of the CFE application.

It is also brought to your notice that Establishment of the industry without having valid consents of the Board is violation of Section 25/26 of Water Act and Section 21/22 of Air Act which is punishable under section 44 of the Water (Prevention and Control of Pollution) Act, 1974 and under section 37 of the Air (Prevention and Control of Pollution) Act, 1981.
